Key Findings

The August 2016 Franklin & Marshall College Poll of Pennsylvania shows that Hillary Clinton leads Donald Trump 47% to 40% among likely voters, down from the 49% to 38% lead she held immediately after the Democratic convention. More voters continue to believe Secretary Clinton rather than Mr. Trump has the experience to be president and is better prepared to handle foreign policy issues, although they are evenly divided on which candidate has the ability to fix the country's economic problems and which candidate will best protect the US from terrorism. Secretary Clinton's favorable ratings have declined since the July survey, falling from 47% to 38% favorable. In the US Senate race, Democrat Katie McGinty has a five-point lead over Republican Senator Pat Toomey 43% to 38% among likely voters, up from a one-point advantage in late July, although one in five (18%) voters is still undecided. Only one in three (33%) registered voters believes Senator Toomey has done a good enough job to deserve re-election.

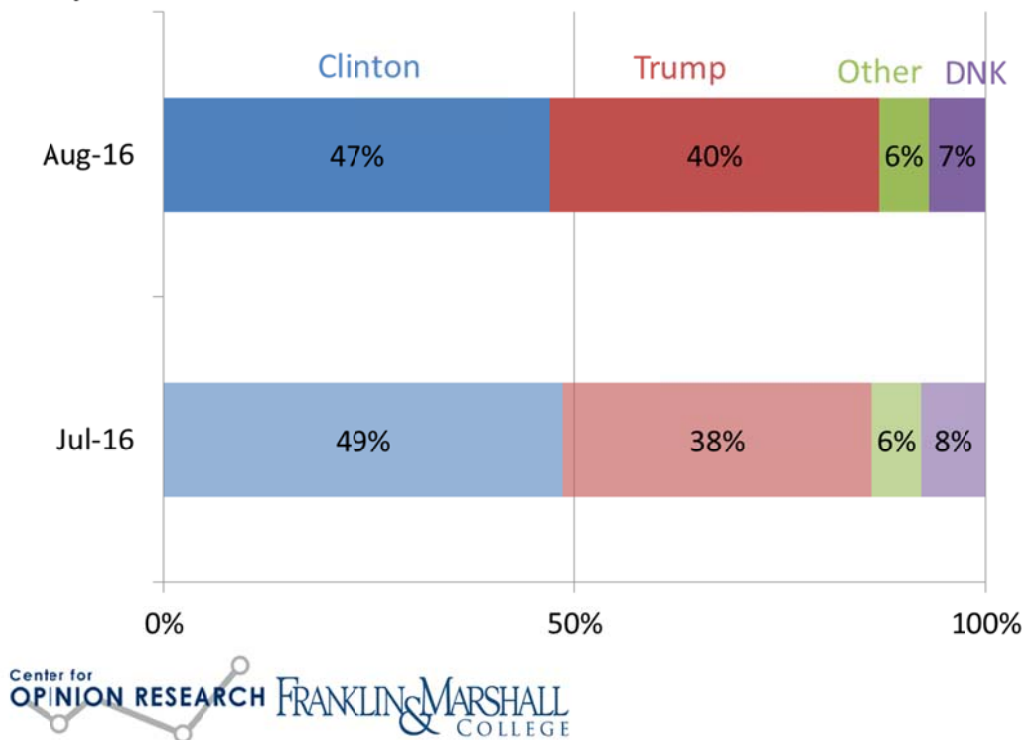
The Presidential Race in Pennsylvania

Hillary Clinton leads Donald Trump 47% to 40% among likely voters. Her lead is smaller among registered voters, 43% to 39% (see figure 1). In a change from our July survey, about equal proportions of registered Democrats support Secretary Clinton (75%) compared to registered Republicans who support Mr. Trump (73%). Secretary Clinton leads among more sub-groups than Mr. Trump, although Mr. Trump leads among those in the lowest education groups, those living in rural counties, and self-described conservatives. There are regional differences in the support for the candidates as well. The current preferences among key demographic groups are displayed in Attachment A-1.

Pennsylvania is important to Mr. Trump's election chances because it has a sizable number of white voters, a demographic subgroup whose presidential preferences analysts have been closely following this year. Mr. Trump holds a sizable advantage among whites with a high school degree or less (52% to 35%), but Secretary Clinton has a similar advantage among college-educated whites (50% to 29%). Mr. Trump also has an advantage among white men (41% to 38%), but his advantage is smaller than Secretary Clinton's lead among white women (45% to 38%). Secretary Clinton's margin among white women is smaller than it was in July.

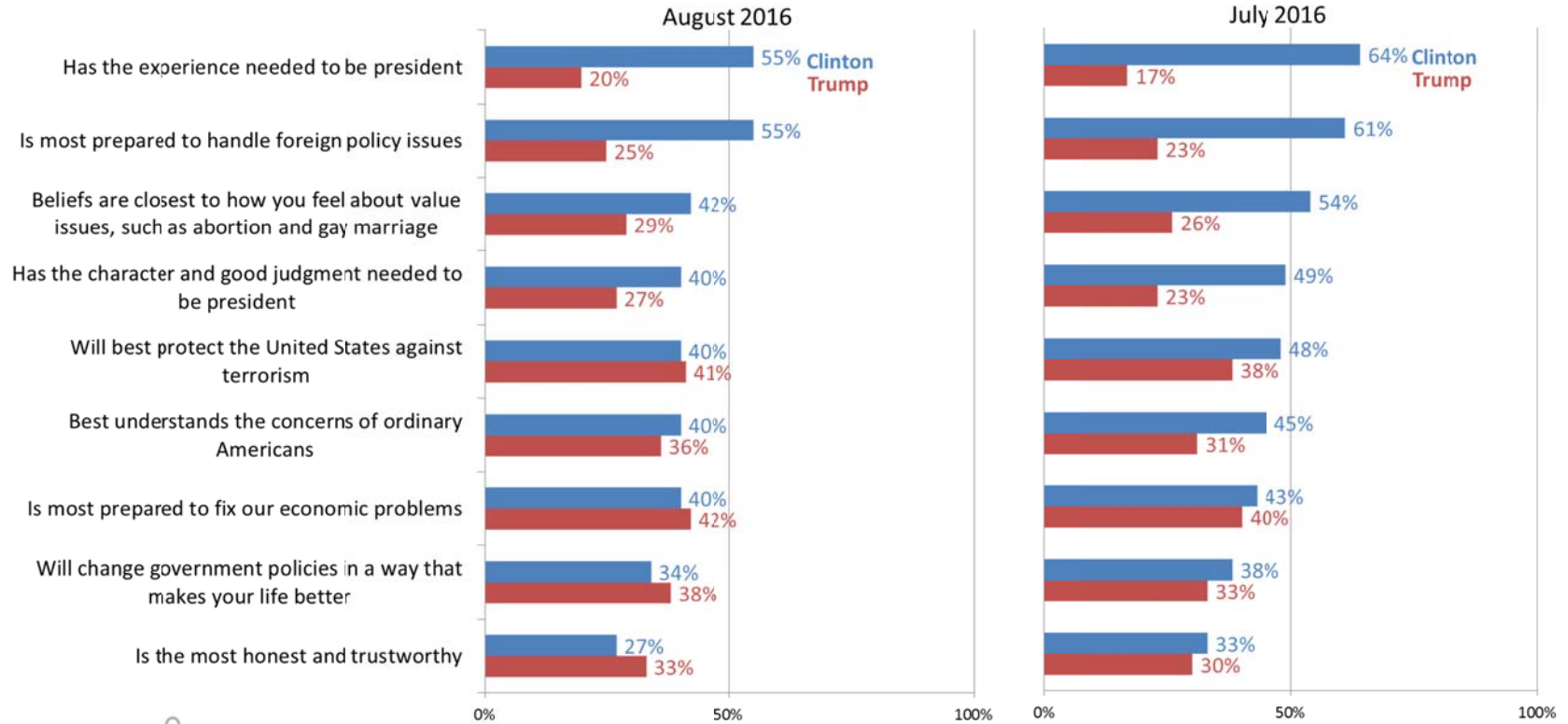
Both candidates have seen their net favorability fluctuate since the primary election in April, although both continue to have a net negative rating. Secretary Clinton is viewed favorably by 38% of registered voters (47% in July) and is viewed unfavorably by 54% (49% in July), giving her a net favorable of minus 16 which is a significant decline from her minus 2 net favorable rating after the Democratic convention. Mr. Trump is viewed favorably by 37% of registered voters (33% in July) and is viewed unfavorably by 58% (62% in July), giving him a net favorable rating of minus 21.

Registered voters tend to believe Secretary Clinton has an advantage over Mr. Trump on a number of important characteristics. A majority of voters believes Secretary Clinton rather than Mr. Trump has the experience to be president and is better prepared to handle foreign policy issues. Voters are about evenly divided on which candidate has the ability to fix the country's economic problems and which candidate will best protect the US from terrorism (see Figure 2).

Regardless of how (or if) you plan to vote, which of these Presidential candidates do you think is best described by each of the following statements?

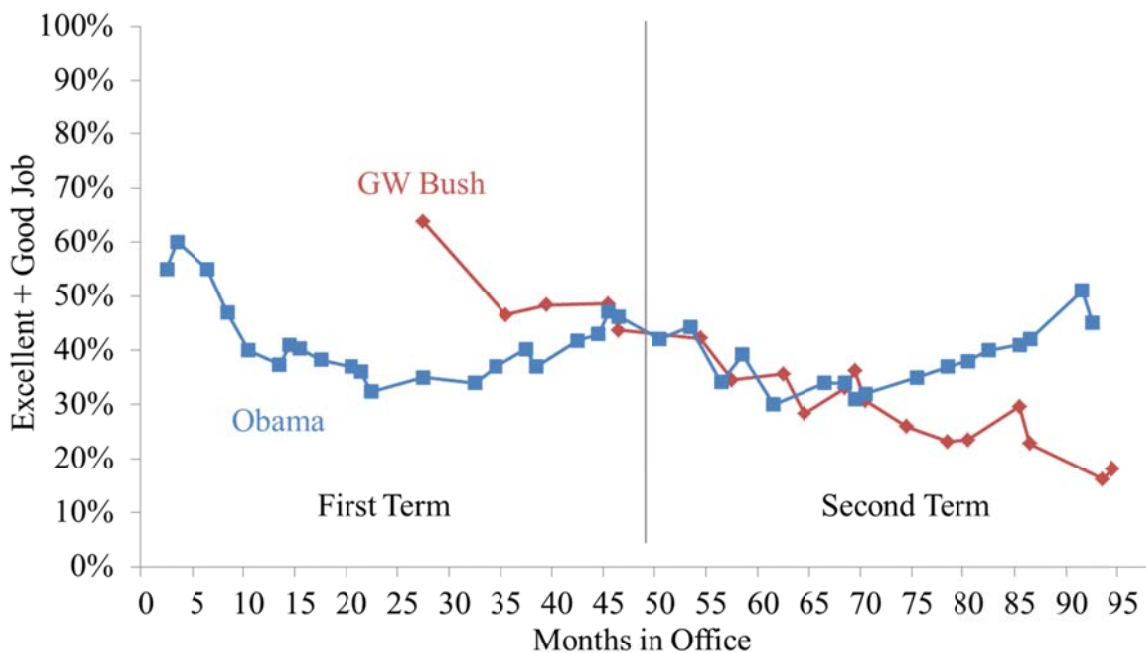


Voters' judgments about the performance of President Obama appear related to their presidential preferences. Nearly half (45%) of registered voters rate President Obama's job performance as excellent or good (see Figure 3). Nearly nine in ten (85%) of those who believe the President is doing an excellent or good job plan to vote for Secretary Clinton, while seven in ten (68%) who believe he is doing only a fair or poor job plan to vote for Mr. Trump.

The differences in specific estimates between the July and August surveys likely result at least in part from differences in partisan self-identification for each sample. Although estimates for the party registration variable (Are you currently registered as a Republican, a Democrat, and Independent, or as something else?) are the same for each survey, estimates for the party self-identification variable (Regardless of how you are registered, in politics as of today do you think of yourself as a Republican, a Democrat, or an Independent) are notably different. The July survey showed 39% self-identified as Republican and 53% self-identified as Democrat, which provided Democrats with a plus 14 self-identification advantage. The August survey showed 45% self-identified as Republican and 47% self-identified as Democrat.

Secretary Clinton's election prospects in Pennsylvania today are quite similar to recent Democratic presidential candidates (see Table 1). Her personal unfavorability scores are a bit higher than President Obama's in 2012 and 2008 or John Kerry's in 2004, but Donald Trump's unfavorability scores are much higher than those of the Republicans in those races. The president's job performance scores are also much better than were President Bush's in 2008; President Bush's poor job performance ratings were undeniably a drag on the Republican ticket at the time. Compared to the last two elections, registered voters feel better about their personal economic conditions. Voter interest is higher this August than in the three previous elections.

The U.S. Senate Race in Pennsylvania

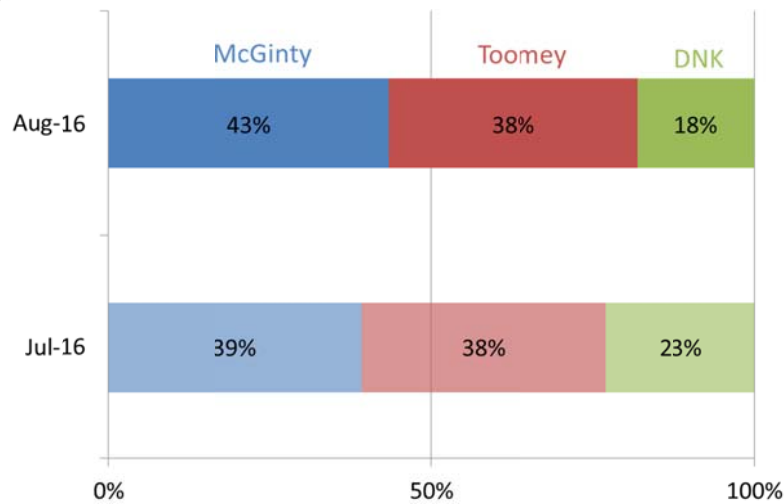
Democrat Katie McGinty has a five-point lead over Republican Senator Pat Toomey 43% to 38% among likely voters; the race is essentially tied among registered voters, 36% to 37% (see figure 4). Table A-3 displays US Senate preference among demographic subgroups. Senator Toomey is currently viewed favorably by one in four voters (29%, up from 23% in July) and unfavorably by two in five (37%, down from 40% in July) voters. Mrs. McGinty is viewed favorably by one in four (28%, up from 25% in July) voters and unfavorably by about one in four (29%, up from 25% in July) voters.

Senator Toomey’s job performance rating is low—only one in four (29%) voters believes he is doing an excellent or good job as US Senator compared to half (53%) who think he is doing a fair or poor job. Importantly, only one in three (33%) registered voters believes he has done a good enough job to deserve being re-elected, but this is an increase from the one in four (24%) voters who felt that way in July.

Methodology

The survey findings presented in this release are based on the results of interviews conducted August 25 - 29, 2016. The interviews were conducted at the Center for Opinion Research at Franklin & Marshall College on behalf of the Center for Politics and Public Affairs. The poll was designed and administered by the staff of the Center for Opinion Research. The data included in this release represent the responses of 736 Pennsylvania registered voters, including 358 Democrats, 286 Republicans, and 92 Independents. The sample of registered voters was obtained from Labels & Lists. All sampled respondents were notified by letter about the survey. Interviews were completed over the phone and on-line depending on each respondent's preference. Survey results were weighted (age, gender, region, education, and party registration) using an iterative weighting algorithm to reflect the known distribution of those characteristics as reported by the Pennsylvania Department of State.

The sample error for this survey is +/- 4.6 percentage points when the design effects from weighting are considered. The sampling error for the 496 likely voters is +/- 5.6 percentage points. In addition to sampling error, this poll is also subject to other sources of non-sampling error. Generally speaking, two sources of error concern researchers most. Non-response bias is created when selected participants either choose not to participate in the survey or are unavailable for interviewing. Response errors are the product of the question and answer process. Surveys that rely on self-reported behaviors and attitudes are susceptible to biases related to the way respondents process and respond to survey questions.
